When do you plan for learners to undertake these assessments?	Unit 1: Devised Drama: We will conduct exams in the week beginning 22 nd March, with any further performances required to be conducted in the Summer Term. Pupils will be given a specific exam slot and advance notice of their exam performance ahead of this time. Unit 3: Interpreting Theatre: Learners will be engaged in looking at relevant Past Papers throughout the Summer Term. The XXXX paper Section A will be used over 5/6 lessons. The formal assessment process will begin on the
	week beginning the 19 th April. The XXXX paper Section B which involved watching Recorded Theatre will be used over 6/7 lessons. The formal assessment process will begin on the week beginning the 3 rd May.
How will you ensure that these assessments are delivered consistently by	A department meeting will take place on 25 th March 2021 where every member of the department will take part in a training to explain the control conditions for each assessment. Assessment procedures for Unit 1, and 3 (XXXX) will be in line with WJEC control measures.

Assessment Front Cover 2021 Cover sheets will be provided for every assessment sat by every pupil which will detail the instructions to candidates and the timings of the assessments, thereby ensuring a standard approach. The sheets will also contain declarations from teachers and students regarding the use of access arrangements and the allocation of marks for each question on the paper. These will undergo a clerical check as per the School Centre Assessment Policy. Pupils will not be permitted to resit assessments.
