(a) (v) removed = 6 marks) because students have not had sufficient access to opportunities in interpreting OS maps This is only a six mark question out of a total 79 marks so represents less than 8% of the total marks. The Bassaleg School adapted Unit 1 retains the necessary depth and breadth of coverage along with the level of challenge and skill coverage required by the subject specification. This paper is Quality Assured by the department Leader of Skills.
	The XXXX Unit 2 paper will be altered to remove Q1. (a) (iv) = 4 marks, Q2. (a) (v) = 2 marks and Q 2. (a) (v) = 4 marks removed in order to reduce the number of marks on this paper to have parity with the Unit 1 paper and ensure questions can be completed in one lesson. These three questions account for 10 marks out of a total 83 marks so represents 12% of the total marks. The Bassaleg School adapted Unit 2 retains the
